Lunaria is an association of social promotion born in Rome in 1992. It promotes the "principles of justice and social and economic solidarity, democratic participation in community life, the promotion of civil, social and human rights at national and international level" (article 3 of the Statute).

To contribute to the realization of these principles the association carries out international voluntary activities, youth work, training, information and research on migration and racism, alternative economy and other global movements.

Lunaria promotes human rights and equal opportunities to build a more equal world in which:

- · Human rights are more relevant than the interests of the major economic powers;
- · Assets, rights and basic services are guaranteed to everybody;
- · Social commitment and solidarity do not become business;
- · Information is free and independent;
- · Rights of citizenship are indipendent from nationalities.

Lunaria in an association independent and autonomous from political parties and it finances its activities thanks to the contributions of public and private institutions, the European Commission and the members. The type of activities and the approach to its mission characterizes its international orientation and attitude to networking.

Lunaria has a staff of 12 people supported by a network of over 35 permanent volunteers who support the office work. The structure, small and agile, is represented by an Executive Committee composed of the President, the Vice-President and three members elected by the Assembly.

Migration and the fight against racism

Since 1996 Lunaria promotes research, public awareness campaigns and information initiatives on the issues of migration and racism. All activities are supported by an extensive network with local, national and European organizations.

Social research and analysis are conceived as fundamental instruments to support initiatives and campaigns aimed to defend the rights of migrants and takle discriminations, racism and xenophobia, as well as to advance sound proposals for alternative and sustainable public policies. This approach has allowed to develop an in-depth understanding of the migration phenomenon, not only regarding the reality of Rome and Italy but also Europe, with particular reference to the processes of inclusion-exclusion in the labour market, the serious barriers that prevent immigrants access to social services (the House, health services) and the evolution of contemporary forms of racism.

	human rights violations in CIE and accommodation centers for refugees. By 2016 the campaign
2017	receives the support of Open Society Foundation.
2015	Carta di Roma. Lunaria, along with other 16 civil society organizations, is one of the founders
	of the Association's of Carta di Roma (Card of Rome), founded on December 2011 with the
	goal of implementing the Journalist's Code of Conduct on immigration, signed by the
	National Council of Journalists (CNOG) and the National Federation of the Italian Press
	(FNSI) in June 2008. Carta di Roma wants to raise awareness in information operators of the
	importance to hire a greater correctness on the treatment of news related to immigration,
	asylum and minorities, also thanks to the implementation of training course, monitoring of the
	press through the Observatory of Rome's Paper and reporting to national associations of
	journalists violations of ethical protocol.

International volunteering

During 2015, Lunaria has involved 459 Italian volunteers in international volunteer camps and hosted 235 foreign volunteers in its workcamps in Italy. It was possible thanks to the collaboration with various associations belonging to the network Alliance of European Voluntary Service Organisations: http://www.alliance-network.eu, whose is part Lunaria. Alliance brings together over 50 organizations that promote international volunteering worldwide.

In Italy, Lunaria collaborates with various local organizations and active associations in society that include, in its activities, a short-term volunteer project making use of international voluntary collaboration.

Lunaria also promotes experiences of medium and long-term volunteering, such as the European Voluntary Service and volunteer projects, both individual and group, targeted adults.

1992-2015	International volunteering Since1992, Lunaria promotes international volunteer activities opened to everyone, which consists of workcamps (2/3 collective experiences of short duration-weeks) and in individual mobility of medium and long term (1-12 months). Every year Lunaria organizes about 30 projects in Italy and involves about 400 people in workcamps abroad and about 300 in Italy. Since 2013, Lunaria organizes volunteer workcamps for minors, responding to a growing interest by families and schools towards this type of learning experiences.
2014-2015	I've. The two-year project aims at promoting the recognition of skills acquired in international volunteering. This is a strategic partnership of Erasmus +, co-founded by the National Youth Agency.
2014-2015	Act 80+. According to Eurostat data, the 40% of EU octogenarians is healthy, independent and motivated to participate in active citizenship. Lunaria is a partner of the EU Erasmus plus programme Active80 project dedicated to the enhancement of knowledge and skills of people with more than 80 years of age.
2014-2015	Forage. The project <i>ForAge. Learning at older ages</i> was completed in 2015 and Lunaria was the italian partner. Forage was supported by the EU Grundtvig programme and aimed at spreading information and best practices related to active ageing.
2014-2015	ComeON! Two generations for social innovation. Lunaria has been partner of the project funded by EU Grundtvig programme led by the Fondazione Mondo Digitale, which experienced the interactions between youth and seniors in the development of innovative projects for the community. Through intergenerational learning modules, designed to motivate and activate cooperation between the two groups, have adopted participatory methodologies and digital platforms to embody the multiple dimensions of civic engagement and of the "education for life", Anglo-Saxon declination of the concept of education for complexity and relations, of which the volunteer is a terrific tool.

Youth exchange, training and youth initiatives

Lunaria promotes training for youngsters and intercultural exchanges and initiatives at local, national and European level. Learning is conceived as a process that lasts a lifetime and is developed with different tools and methods.

Lunaria activities aim at facilitating the acquisition of new theoretical knowledge, practical, interpersonal and soft skills: the ability to work in a team, to interact with others, opportunity to learn languages, intercultural dialogue and to exchange of experiences. Peer education, knowledge and exchange of experiences among peers and learning by doing are key elements of Lunaria working method.

During 2015, Lunaria involved in youth exchanges, training courses and youth initiatives in Italy and abroad about 320 young people, social and youth workers.

2014-2015	Unveiling stories. The training course, funded by the National Youth Agency, aimed at raising awareness of a group of 30 young people from 8 European countries on the theme of racism and xenophobia.
2014-2015	Jambo. Young women empowerment to improve quality of youth work and volunteering in eu and partner countries. The Capacity Building, funded by the National Youth Agency, project included information activities, training and awareness-raising in Italy, France, Spain, Uganda, Kenya and Tanzania aimed at promoting women's empowerment and gender equality. In addition, the project has allowed to develop new non-formal education methods for different local contexts.
2014-2015	Art for civil society dialogue. The project was funded by the European Union under the cultural exchange programme between the EU and Turkey. A week of joint work and cultural exchange between EU and Turkish artists, in interaction with the Faculty of Arts of the University of Denizli, in order to create some artworks on the topic of combating discriminations that were donated to the local museum.
2014-2015	Together. Enhancing youth and csos political culture and democratic participation. The project aimed at developing the knowledge of NGOs and Turk youngsters of European policies and the related opportunities to enhance active citizenship among young people. The project was financed by European action Political Criteria Grant Scheme (CSD-III/PC), Civil Society Dialogue Between EU And Turkey – III.
2015-2016	Pandora's box young women, community development through eu and la cooperation. The Capacity Building project, started in 2015 and ending in 2016, aims to continue the work in the field of women empowerment and gender equality previously started with Jambo. The countries involved are Italy, France, Spain, Mexico, Ecuador and Peru. The project was funded by EACEA Education, Audiovisual and Culture Executive Agency – Erasmus +
2014-2015	The perfect match. Training program to overcome boundaries. The project realized in 2015 allowed to engage young people with and without visual disabilities, social workers and young people active in the field of disability. Through two training courses it has been possible to develop new methods of non-formal education and outdoor techniques to make projects more inclusive. The project was funded by the Youth National Agency under the programme Erasmus +.
2015	Informagiovani of Venice. Lunaria handled until August 2015, after 11 years of collaboration with the Venice City Council and other local organizations, youth information management in Venice. The service was managed with an innovative and participatory approach and has enabled thousands of young men and women to build a part of your future.

Since 1999, more than 46 civil society organizations have come together - on the initiative of Lunaria- in Sbilanciamoci!, a campaign to commit to a equal economy and a new model of development based on rights, respect for the environment and promotion of peace. A detailed analisys of National Financial Laws is aimed to orient public policies towards the realization of the principles of solidarity, equality, sustainability and peace. Sbilanciamoci! assumes that it is necessary to radically change the perspective of public policies, to reverse the economic and social agenda in order to put the focus on solidarity, rights of the people and to protect the environment.
