Lunaria is a non-profit, laic, independent and autonomous non-profit organization with social aims founded in 1992. It promotes peace, social and economic justice, equality and the guarantee of citizenship rights, democracy and participation from below, social inclusion and intercultural dialogue. Lunaria carries out and fosters processes of social change at local, national and international level through advocacy, political-cultural events, communication, non-formal education, training and research, information and awareness campaigns and work in network. International mobility and voluntary work, youth policies, migration and combating against racism, analysis of public budget, economic and social policies, sustainable development and the fight against inequality are at the center of its commitment.

Lunaria promotes the safeguarding of rights and equal opportunities to build a fairer world in which:

- Human rights take priority over the interests of the large economic powers; ·
- Basic goods, rights and services are guaranteed to everyone; ·
- Social commitment and solidarity do not transform into business;
- Information is free and independent; ·
- Citizenship rights are released from nationality.

As an association not affiliated with the parties, Lunaria finances its activities thanks to the contributions of its members, public and private bodies and the European Commission.

The type of activities carried out and the approach to its mission characterize the international orientation of the association and its aptitude for working as part of a network. In 2016, the staff was composed of 13 people assisted by a wide network of volunteers. The small and agile structure is represented by a Presidency Committee consisting of a President, Vice-President, 3 staff members and a permanent delegate elected by the Assembly.

International volunteering

Since 1992, Lunaria has been promoting international volunteering camps: more than 24,000 Italian and foreign volunteers have been involved to date. The camps are based on solidarity and international cooperation: through a concrete, non-profit social activity and the meeting of people from all over the world, camps allow volunteers to experience and practice in daily life the values of dialogue, coexistence, peace. In 2017, Lunaria involved 520 Italian volunteers in the international volunteering camps abroad and hosted 297 international volunteers in the camps realized in Italy in collaboration with local authorities and the other 90 associations belonging to the Alliance of European Voluntary Service Organizations network: <http://www.alliance-network.eu/>, of which Lunaria is part.

Over the last years, Lunaria has devoted particular attention to the promotion of participation of minors and seniors in experiences of international volunteering. The great educational value of this kind of experience and the contribution to the development of participation and active citizenship make it a suitable opportunity for all generations. The long experience gained in the promotion of short and medium term international volunteering initiatives has given rise to specific projects aimed at enhancing the skills acquired by volunteers.



1992-2017	International volunteering. Since 1992, Lunaria promotes an international volunteering program open to everyone, which consists of workcamps (short-term collective experiences - 2-3 weeks) and individual medium and long-term mobility (1-12 months). Every year, Lunaria organizes about 30 projects in Italy and involves about 500 people in projects abroad and about 300 of those in Italy. Since 2013, Lunaria organizes workcamps for underage volunteers, responding to the growing interest shown by families and schools towards this kind of training experience.
1992-2017	Volunteering in Italy. In 2017, Lunaria organized 30 international volunteering camps in Italy with the collaboration of local associations, clubs, cooperatives and other organizations rooted in the territories. Each year new partnerships and new projects are developed. This year, 4 of the 30 projects realized were dedicated to the active participation of young minors from all over the world. One example out of many is the project carried out in collaboration with the social cooperative Il Pungiglione. 10 international volunteers supported the activities of the center "La casa di Arianna" in Civita Castellana, which hosts users with mental disabilities.
2016-2018	NOMADs. This European project, which lasts 3 years, brings together organizations from the Alliance network and from the social sport world in a European partnership, with the aim of launching a mobility program to involve young athletes and volunteers in volunteering camps to support social sport initiatives..
2016-2018	Mobility Scouts. Mobility is one of the greatest limits to the active participation of senior citizens within their communities. 'Mobility Scouts - Involving the elderly for a society for all ages' aims to involve, as co-decision-makers, small groups of elderly people in decision processes, allowing them to contribute to the creation of public spaces and services accessible for the more advanced age groups. The project is co-financed by the European Erasmus + program and Lunaria is partner for Italy.



Youth exchanges, training and youth initiatives

Learning can take place throughout our whole life in different ways and with different methodologies. For this reason, Lunaria has been promoting, since 1993, non-formal education activities for young people at local, national and European level. Youth exchanges and training seminars facilitate the acquisition of cross competences and new theoretical, practical and relational knowledge: the capacity of working in a group, of interacting with other people, of learning languages, the exchange of experiences, the intercultural dialogue. Peer education, knowledge and exchange of experiences among peers, the "learning by doing", are key elements of our work method. In 2017, Lunaria involved about 350 social and youth workers in training courses, youth exchanges and initiatives both in Italy and abroad.

Thanks to the collaboration with the associations of the Alliance network, we had the opportunity to be involved in several youth exchanges and training courses organized by the partner associations, as well as in new capacity building projects. One of them was the Prometheus project of the Concordia association (France), which was held in Ecuador and Peru. There were committed 2 EVS volunteers, 6 of our social and youth workers and there will be others involved in 2018. In 2017, the strategic line of the last few years has been extremely strengthened, focusing on the issues of gender, migration and inclusion.



2017-2018	STAGED! Struggling Against Gender-based Discrimination through Youth Work in EU and Asia. The capacity building project in the field of female empowerment and gender equality continued the work previously launched with the Jambo and Pandora projects. Two international training in South East Asia and one in Italy are involving youth workers, activists and representatives of local communities from Italy, France, Romania, Myanmar, Vietnam and Indonesia. The project was funded by EACEA, Education, Audiovisual and Culture Executive Agency - Erasmus + Program. At the end of the project, a Handbook of the activities carried out in the various actions of the project will be created.
2017-2018	STAGED! International Workcamps for Women Empowerment and Gender Equality in SEA. In 2017, in partnership with the associations CSDS (Vietnam) GREAT (Indonesia) and COM (Myanmar), and thanks to the support of the 8x1000 of the Tavola Valdese, Lunaria will realize in March 2018 three voluntary fields in South East Asia, with the aim of fighting gender discrimination and helping local communities in the daily tasks of safeguarding cultural and landscape assets. Italian volunteers will work together with local volunteers in building a synergy between international volunteering and the local community.
2017-2018	PEOPLE FIRST - Communicating Human Rights in the Migration Era. The project, made up of a training course, aims to promote and develop communication tools and methodologies useful to sensitize local communities about human rights, with a focus on the rights of citizenship and the rights of migrants and refugees. At the end of the project, a Toolkit with a detailed description of the methodologies and of the non formal educational activities carried out will be produced.
2017-2018	GEM- Gender Equality and Migration. The project set itself the goal of analyzing the current phenomenon of the xenophobic hatespeech in a gender key. Participants of the training course and of the youth exchange, which is part of the project, have had the opportunity to try new methods and tools, such as comics, graphic facilitation and photography, aimed to raise awareness among their peers and to attach importance to these issues, common to all the nations involved.
2016-2018	PRISM- Breaking Down Gender Stereotypes in Teenagers Projects. The project, consisting of a training course and a visit that arranged the two summer youth exchanges, brought a gender perspective within the projects for teenagers, developing new methods and tools to raise awareness among young people on this issue. The project involved approximately 30 youth workers and more than 60 teenagers from all over Europe.
2016-2017	THE BUTTERFLY EFFECT - Raising Awareness Among European Youth on the Refugees Crisis. The project, which included a training course, three job shadowing, in Italy, France and Germany, and a youth exchange, aimed at developing tools and methods to sensitize young people and adults in Europe on the diffusion of discrimination and the phenomena of racism and xenophobia. At the end of the project, a Toolkit.
2016-2017	JAMBO. In partnership with the KVDA (Kenya) and UPA (Uganda), associations and thanks to the support of the Tavola Valdese, Lunaria organized two volunteering camps in two communities in Kenya and Uganda, with the aim of fighting gender discrimination and raising awareness of environmental sustainability. Italian volunteers work together with local volunteers in building a synergy between international volunteering and the local community.
2016-2017	THE SOUND OF LIGHT - Exchanging tools and abilities for an innovative and inclusive youth strategy. The project allowed the development of the quality of youth work in the field of disability, focusing on deafness, providing participants - social and youth workers and young people with and without disabilities - new working methods to implement inclusive initiatives and projects. The project included a training course for youth workers, a short-term European Voluntary Service, a planning preliminary visit and a you

2016-2017 THE POT OF GOLD - Education and exchange to fight hate speech and discrimination. The project aimed to fight, through the knowledge and development of particular tools, the emergence and diffusion in youth contexts of hate speech and gender and sexual discrimination. The project included a training course and a youth exchange. A Toolkit was produced



Migrations and the fight against racism

Since 1996, Lunaria promotes research activities, awareness -raising campaigns and information initiatives on migration and racism issues. All activities are supported by intense networking with local, national and European organizations. Research and social analysis are conceived as tools to support the initiatives and the campaigns aiming at defending the rights of migrants and fighting discrimination, racism and xenophobia, as well as making valid proposals for alternative and sustainable public policies. This approach allowed us to develop a deep knowledge of the migratory phenomenon, with particular reference to the processes of inclusion / exclusion from the labor market, the arduous barriers that prevent immigrants from accessing social services, and the evolution of contemporary forms of racism.

In 2017, the analysis, training and advocacy activities aimed at countering racist violence and discourse, also providing an overview of the reality in order to have the necessary cognitive tools to intervene.



2016-2018	Strengthening Lunaria activities countering discrimination and racism. The biennial project, supported by the Open Society Foundations, includes monitoring and research activities on the evolution of racism in Italy, the publication of the Fourth White Paper on Racism and 6 in-depth focuses, the holding of training seminars for the CSOs and advocacy activities for the protection of citizenship rights. In 2017, 2 focuses were published on the topics of reception of asylum seekers and the reform of the citizenship law. The Fourth White Paper on Racism in Italy was also produced.
2011-2018	www.cronachediordinariorazzismo.org. (Chronicles of ordinary racism), information, in-depth and communication website specifically dedicated to the phenomenon of racism. In 2017, the site had a monthly average of 20,000 different visitors per month. The weekly newsletter reaches 5,606 readers. The Twitter profile of Chronicles of ordinary racism has 3,111 followers and the Facebook page is followed by 7738 people. In 2017, the layout of the site was changed and renewed.
2017-2019	MED-looking Youth Shaping EU Policy for a "Ready Europe". The project, funded by the European ERASMUS + program, develops training and information activities focused on racist discourses and actions, on the methodologies and the tools to combat it and on the possible raising awareness actions of local institutions, national and European authorities aimed to strengthen the institutional commitment in this area. The activities include, in particular, the organization of a national workshop in Italy and an international meeting, which involves the other two partner countries of the project (Greece and Spain).
2011-2017	Campagna L'Italia sono anch'io. Lunaria is part of the organizing committee of the campaign "L'Italia sono anche io" (Italy is me too) that collected more than 200 thousand signatures on two bills for the reform of the law on citizenship and the recognition of the right to vote for foreign citizens permanently residing in our country. In 2017, numerous initiatives were organized to urge the Senate to definitively approve the bill on citizenship dismissed by the House on October 13, 2015.
2011-2017	Carta di Roma. (The Charter of Rome) . Lunaria is one of the founders of the association 'Carta di Roma', established December 16, 2011 with the aim of implementing the homonymous ethical protocol of the journalistic profession concerning asylum seekers, refugees, victims of trafficking and migrants, signed by Consiglio Nazionale dell'Ordine dei Giornalisti and Federazione Nazionale della Stampa Italiana. Carta di Roma sensitizes information operators to a greater accuracy in dealing with news concerning immigration, asylum and minorities, through training activities, monitoring of the press and publication of an annual report.



The Sbilanciamoci! campaign

Since 1999, 48 civil society organizations - on the initiative of Lunaria - have joined in the Sbilanciamoci! Campaign in order to create an economy of justice and a new model of development based on rights, peace and the environment. Since then, Sbilanciamoci! proposes and organizes every year activities of denunciation, awareness raising, pressure, political and cultural initiatives, aiming at addressing politics, economy and society towards solidarity, equality, sustainability and peace. Sbilanciamoci assumes that it is necessary to radically change the perspective of public and budgetary policies, overturning economic and social priorities in order to focus on solidarity, people's rights and the protection of the environment, rather than on the privileges, waste, inequality of the market economy. Every year the campaign publishes the Report Sbilanciamoci! which critically analyzes the State Annual Budget Law and makes detailed proposals for alternative policies on 1) tax and finance, 2) industrial policies, 3) labor and income, 4) environment and sustainable development, 5) culture and knowledge, 6) welfare and rights; 7) cooperation, peace and disarmament, 8) alternative economy.

During its 19 years of activity, the campaign has developed a large number of research tools, critical analysis and proposals and it has organized dozens of public initiatives throughout Italy. For information: www.sbilanciamoci.org.



Sbilanciamoci.info

The site www.sbilanciamoci.info was born from the activity of Sbilanciamoci! in 2008. It is a communication tool on economic alternatives promoted by a group of economists, researchers, journalists, students, social workers, trade unionists, linked to the network of associations, organizations and movements that are part of the campaign. The site wants to rebalance the dissemination of information, to broaden their scope and open the debate to different points of view from the neoliberal leading one; to know, update and enhance the tools of economic policy in the globalized economy; to rethink the agenda of the economic policy and of politics in general focusing on the urgency of climate change and imbalances in the global distribution of wealth and income; to describe and analyze the practical experiments on new economic and organizational models. From 2008 to 2016, more than 2,500 articles were published, drawn up by around 500 partners. In 2017, the newsletter was sent to an average of 15,000 subscribers, the Twitter profile reached almost 5,000 followers and the Facebook page exceeded 3,500 contacts. www.sbilanciamoci.info

2017	How to use public expenditure for rights, peace and the environment. In 2017, the campaign published the nineteenth Report Sbilanciamoci! 2018 "How to use public expenditure for rights, peace and the environment". A counter-proposal of € 44.2 billion, articulated in 111 proposals that responds to the policy of a government unable of imagining the future, accompanied by a precise analysis of the State Annual Budget Law. Once again, with his proposals Sbilanciamoci! demonstrates that politics could improve the Italian social and economic situation establishing different policies. Furthermore, there is an online platform dedicated to the Report (controfinanziaria.sbilanciamoci.org) that hosts data, graphics and interactive infographics.
2017	Sbilanciamo Bologna. Understand and change the local budget. After the two editions of "Sbilanciamo le città. Understanding and changing local budgets", which were successfully held in Rome in July and December 2016, in 2017, Sbilanciamoci!, together with Openpolis, organized the first local edition of the seminar aimed at citizens and members of associations, groups, movements, parties and trade unions.
2017	Sbilanciamo i conti pubblici. Fourth edition of the seminar of Sbilanciamoci! on the state budget procedures (and specifically the Annual Budget Law 2018): an opportunity to learn to understand the process and budgetary choices, the financial measures and the constraints of public finance. The two days of training integrated and enriched the former course on reading the municipal budgets launched in 2016 with Openpolis.
2016-2018	Open Budget Survey. Sbilanciamoci! is in charge of the monitoring and the analysis of the Open Budget Survey of Italy, part of the most important independent global report on the transparency of public budgets written by IBP, (International Budget Partnership), the network of more than 100 associations from countries all over the world (http://www.internationalbudget.org/opening-budgets/open-budget-initiative/open-budget-survey/).
2015-2018	ISIGrowth. Sbilanciamoci manages the communication and the networking part of "ISIGrowth - Innovation-Fuelled, Sustainable, Inclusive Growth", a research project funded by the European Commission under the Horizon 2020 program (http://www.isigrowth.eu/). The aim is to promote a more equitable and sustainable growth also through the interaction between the partner Universities and CAN, a network of European civil society organizations, whose task is to translate the analysis developed in the project into concrete policy proposals for European decision makers.
2014-2017	Campaign Stop Ttip. Also in 2017, Sbilanciamoci! actively participated to the Campaign, that was born in 2014, in order to coordinate organizations, networks and territories that

	oppose the approval of the Transatlantic Partnership Treaty on Trade and Investments (TTIP).
2014-2017	Campaign "Un'altra difesa è possibile". The proposal for the establishment of a Department for unarmed and non-violent civil defense, at the Presidency of Council, continues under the push of the campaign "Un'altra difesa è possibile" (Another Defense is Possible), promoted and supported by the Conferenza Nazionale Enti di Servizio Civile, Forum Nazionale per il Servizio Civile, Rete della Pace, Rete Italiana per il Disarmo, Sbilanciamoci!, Tavolo Interventi Civili di Pace.
