AIM

to enhance gender equity and young women empowerment by providing youth workers, peer educators, local organizations and international NGOs, in EU and Mediterranean countries, with new tools and methods, training modules and pedagogical approaches to raise youth awareness on gender-sensitive issues, both within the local communities and at international level.

THEME

Gender equity and women empowerment through youth work methods and approaches.

In this perspective, **non-formal education** and **youth work** are seen as a tools to promote **gender awareness** and **gender equity** by enhancing young women participation and empowerment within the local communities in EU and Mediterranean countries.

METHODOLOGY

The whole project will be based on **non formal education - NFE** methodologies and a **learning by doing approach**, to better target the actions to better achieve the specific objectives.

It is forecast the possibility to re-adapt the methods during the process, taking into account the needs of participants and of the different actors involved. This decision due to the interest of bringing flexibility to the learning experience, encouraging the different learning approaches and the activation of the individual skills.

IMPORTANT NOTE: By filling the specific application form, participants can express their preference between the different ITCs according to their interest. However, it is warmly suggested to participate in each action in order to experience a complete and coherent learning process.

TRAVEL costs and refund

The travel costs are considered eligible only if the participants come from and return to the country of the sending organisation. Participants are expected to arrive on the official arrival day and leave on the official departure day of the project: late arrival (for example on the second day of activities) and early departure (for example, before the last day of the activity) are not allowed.

Moreover, participants, informing the organizations in advance, are warmly invited to opt for the **green travel** using more sustainable and eco-friendly means of transport (train, buses and carpooling).

FIRST IMPORTANT NOTE: Only for <u>participants</u> who choose the Green <u>Travel</u> option have 4 days of flexibility (arrival and departure days not included) to travel to the venue. They can manage in the most suitable way for them (e.g. 2 extra days before the official arrival + 2 extra days after the official departure day; 1 extra day before the arrival, 3 extra days after the departure day).

SECOND IMPORTANT NOTE: Lunaria will send the Infosheet only after having filled the application forms and being selected. The Infosheet contains all the details to prepare for the journey and the whole experience.

FOOD AND LODGEMENT COSTS for all the ITCs

INSURANCE
